We, the undersigned natural persons of the age of twenty-one years or more, do make and acknowledge these Articles of incorporation for the purpose of forming a non-profit morporation under and by virtue of the laws of the State of North Carolina.

- I. The name of the corporation is GLEN COVE PROPERTY OWNERS ASSOCIATION, INC.
  - 2. The period of duration of the corporation is perpetual.
  - 3. The purpose for which the corporation is organized are:

To acquire, hold, maintain and operate parks, reads, canals, boat ramps and other properties and improvements as recreational and utility facilities for the subdivision known as Glen Cove, located in Salem Township, Pasquotank County, North Carolina, for the use and enjoyment of the members of this corporation.
